1. **The Municipal Government of Mapandan, Pangasinan**, through the DILG-LGSF-ADM 2017 Fund, intends to apply the sum of **Php14,075,999.82** being the Approved Budget for the Contract (ABC) to payments under the contract for **Concreting of Farm-to-Market Roads at 6 Brgys, Mapandan, Pangasinan at Amanoaoc, Golden, Luyan, Pias, Poblacion & Primicias, Mapandan, Pangasinan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipal Government of Mapandan, Pangasinan, now invites bids for **Concreting of Farm-to-Market Roads at 6 Brgys, Mapandan, Pangasinan**. Completion of the above-mentioned contract is required within **182 calendar days** upon issuance of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the BAC Secretariat, Municipal Government of Mapandan, Pangasinan and inspect the Bidding Documents at the address given below during Mondays to Fridays at 8:00 AM to 12:00 Noon and 1:00 PM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on July 27, 2017 to August 14, 2017 at the address below and upon payment of non-refundable amount of **One Thousand Pesos (Php1,000.00)** for **Annual Contractor’s Accreditation Fee** and **Twenty Five Thousand Pesos (Php25,000.00)** for bidding documents to the *Mapandan LGU Treasurer’s Office*. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (if any), provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
6. The Municipal Government of Mapandan, Pangasinan, will hold a **Pre-Bid Conference** on **August 3, 2017, 10:00 AM** at Mapandan LGU Conference Hall, Mapandan, Pangasinan, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **10:00 AM of August 15, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. **Bid opening** shall be on **August 15, 2017 at 10:00 AM** at Mapandan LGU Conference Hall, Mapandan, Pangasinan. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **Municipal Government of Mapandan, Pangasinan**, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
